10. Owners agree to wear a certified helmet at all times while mounted and not to ride on the premises until there is another person present. TLC Equestrian Center, LLC suggests that each owner carries a health insurance policy on their horse.
11. The owner agrees that pictures taken of them and/or their horse at TLC or a TLC sponsored event can be used for marketing purposes in brochures and/or on the website.

Worming Schedule:

Owner is advised that the Center will administer wormer on the following schedule and bill the Owner for the cost of the wormer. Changes may be made to the following schedule upon a veterinarian's suggestion.

The Center will schedule a veterinarian to administer spring and fall shots as follows. Owner may schedule his/her own veterinarian as long as they meet the veterinarian for the appointment. Changes may be made to the following schedule upon a veterinarian's suggestion.

Dentist / Teeth Floating:

The Center will schedule a certified dentist to check and/or float your horse's teeth in January and June of each year. Owner is also welcome to use their own dentist as long as they meet their dentist for the appointment.

Farrier Services:

The Center will schedule a farrier to properly shod and maintain your horses' hooves. Owner agrees to promptly pay said bill. Owner may schedule their own appointment with their choice of farrier as long as the farrier is approved by the Center. In this case, the owner is required to meet the farrier for each appointment.
